

KEY ACCOMPLISHMENTS

Work-Based Learning Navigator

Employment Services of Weld County (ESWC) created a Work-Based Learning (WBL) Navigator position in September 2021. This position aims to foster new employer relationships, including outreach, education, and information sharing about WBL activities and services to increase opportunities available to individuals throughout Weld County. This includes identifying high-demand occupations and strengthening relationships with related training providers in the industry. This will enable Weld County businesses to develop preapprenticeships and registered apprenticeships under the United States Department of Labor and the Colorado Office of the Future of Work. During PY21, the WBL Navigator engaged with local employers to connect them with WBL services and partners that best met their needs, resulting in multiple new WBL worksites across healthcare, agriculture, construction, and information technology industries.

Re-Skilling, Up-Skilling, and Next-Skilling (RUN) Workers Program

ESWC received \$1,416,012.00 for the four-year Re-skilling, Up-skilling, and Next-Skilling (RUN) Workers Program under House Bill 21-1264 Coronavirus State and Local Fiscal Recovery funds. These funds will support participants by allowing access to short-term training to obtain industry-recognized credentials. ESWC has assisted participants in obtaining credentials for the following: Commercial Drivers License, Dental Assistant Certificates, Emergency Medical Technician, Fire Service Training Academy, Medical Assistant, Microdermabrasion and Chemical Peel; OSHA 50 & 511, Police Academy, S-212 Wildfire Chain Saws, Sterile Processing Technician, ServSafe Food Manager Certificate, Certified Nurse Assistant, Medical Laboratory Science, and Welding Certificates. RUN Program participants are co-enrolled into other programs housed within ESWC and referred to partners and other supportive services.

Workforce Innovation Grant for States (WIGS)

The Weld County Workforce Development Board (WCWDB) received \$1,194,228.00 in Workforce Innovation Grant for States (WIGS) funds under Colorado House Bill 21-1264. The WCWDB put out requests for proposals and awarded five grants to four local organizations for new program development; expand access to existing programs; outreach and engagement, especially to marginalized or disproportionately impacted populations; as well as career coaching and navigation for individuals.

- IRCNOCO was awarded \$336,138 for their Basic Education and Digital Literacy Development Program offering the NorthStar Digital Literacy Industry Recognized Credential. They plan to serve 98 participants and five (5) classes of ESL, workplace readiness, and digital literacy per year.
- Jobs of Hope received two awards, \$161,700 and \$46,257.94, for the House of Hope, Men of Valor program. They plan to serve 40 participants per year.
- Colorado Bioscience Institute in conjunction with the St. Vrain Valley School District, was awarded\$435,200 for their Warrior Tech Associates Degree in Biochemistry. They plan to complete three (3) cohorts with 30 students each.
- Northern Colorado Veterans Resource Center (NCVRC) was awarded \$130,935 for Employer Engagement Support to enhance current resources and provide employment assistance and new technology to help Veterans who are re-integrating into civilian life as well as helping businesses understand how to work with Veterans when hiring.
